We know the holiday season can take a real toll on the wallet. To help out your holiday budget, we're offering you the chance to skip your loan payment(s)* during the holiday season.

Skip a loan payment in either November 2020, December 2020 or January 2021 on each qualifying loan for a small processing fee of \$25 each. The completed form must be received before the due date as specified below. *PLEASE NOTE: Loans with prior skip-a-payment(s) granted since February 2020 (COVID-19 or other) are not eligible.*

Apply today to skip your loan payment this holiday season!

One form per loan — Check one monthly payment on each qualifying loan for \$25 per payment skipped!

*By signing, I authorize Georgia Heritage FCU to advance my loan payment by one month and acknowledge that this may extend the maturity date of my loan. I acknowledge that this does not change my legal obligation to the Credit Union. Interest will continue to accrue on the unpaid balance during the month I skip my payment at the contractual rate; and when payments resume, the unpaid interest will be collected first. At least six full monthly payments must have been received and the loan be paid current to qualify, with no previous skip-a-payments (COVID-19 or other) having been granted since February 2020. A signed, completed skip a payment form must be received before the above designated due date. Georgia Heritage FCU reserves the right to refuse any skip a payment request and previous delinquent payment history on any loan could affect eligibility. First mortgage, home equity loans, personal lines of credit, Phoenix credit rebuilder loans, certain share certificate secured loans, and credit cards are excluded. If I have purchased credit life, credit disbility, gayment will resume immediately following the month skipped.

Coronavirus Scams Prevention Methods

As COVID-19 rages on, so does the cybercrime related to the virus. Scammers are taking advantage of the pandemic to con people into giving up their money and they're using a full suite of scam tools to do so. During this time of uncertainty, knowing how to prevent scams is key. Use these prevention methods to get started.

- **1. Beware of phishing scams -** Do not click on links or open any attachments or pop-ups from unfamiliar sources, and do not give your password, account number or PIN to anyone.
- **2. Ignore offers for a COVID-19 vaccine -** If there is a medical vaccine available or other treatment, it wouldn't be reported through unsolicited emails or online ads.
- **3. Rely on official sources for the most up-to-date information -** Visit the Centers for Disease Control and Prevention, World Health Organization, and your state's health department websites to keep track of the latest developments.
- **4. Research before making a donation -** Be cautious of any business, charity, or individual requesting coronavirus-related donations in cash, by wire transfer, gift card or through the mail.
- 5. Keep your computers and mobile devices up to date The latest security software, web browser, and operating systems are the best defenses against viruses, malware, and online threats.
- **6. Enable MFA -** Multi-factor authentication is an important second step to verify who you are on certain accounts, like a text with a code.
- **7.** Thoroughly research investment opportunities You should be suspicious of any company claiming the ability to prevent, detect or cure COVID-19.
- **8. Report coronavirus scams -** Visit <u>www.ic3.gov</u> to report scams and you can learn more about the latest scam types by visiting <u>ftc.gov/coronavirus</u>.

5 tips for charitable giving

Considering giving more to charity this year? Use these tips to ensure your goodwill is appropriately accommodated and that you earn any associated tax benefits for 2020.

- 1. Donate early and complete your gift by December 31st A gift by check is complete when mailed (postmarked) to the charitable recipient, even if not cashed until the following year. Gifts by credit card are complete when your credit card account is charged. Gifts of stock and real estate are more complex so you'll want to make sure you have enough time to make the necessary arrangements.
- **2. Consider your income** Take time to understand your tax liability for the year. Did your unearned income increase? Did you sell any appreciated assets? The answers may determine how much you want to give.
- 3. Research the charity Unfortunately, there are fraudulent charities that will take advantage of your goodwill. To avoid this situation, ask for written information about the organization. A legitimate charity will give you information about their mission, how your donation will be used and proof that your contribution is tax deductible.
- **4.** Discuss Your Strategies With a Professional Speak with your accountant or financial adviser to ensure your contribution is appropriate to your situation.
- **5. Designate your gift -** Some charities will permit you to specify exactly where your gift is going and for what specific need. This helps you control where your donation goes and whom it helps.
